

We The People Demand Your Immediate Resignation

Dear public servant Pritzker,

We THE PEOPLE of THE Republic for the United States of America are informing you that you must resign immediately. This is THE PEOPLE'S most current petition for grievances and a demand for your resignation. You have not protected the United States Constitution, you have perpetuated a destructive government and you have come against THE PEOPLE and Our God given unalienable rights, our Bill of Rights, all of our founding documents and much more.

The Declaration of Independence clearly states it is THE PEOPLE'S right and duty to replace a destructive government. At no point does The Declaration of Independence state we must recall you or arrest you. It is not THE PEOPLE'S responsibility to do so. The Declaration of Independence simply states it is THE PEOPLE'S right and our duty to replace you. We intend for this entire process to be peaceful. In order to replace you peacefully, you obviously must announce your resignation to the public and vacate the position.

You fraudulently became a public servant under the UNITED STATES Corporation. The Republic for the United States of America has operated in parallel with the *de facto* Corporate UNITED STATES for many years. You unlawfully led THE PEOPLE to believe that you took a sworn oath to support and protect The United States Constitution against all enemies foreign and domestic while you actually took an oath to defend a for profit corporation. The peaceful parallel has unfortunately become hostile with intent. THE PEOPLE are well aware that a for profit corporation is unlawfully acting as the government. You are aiding and abetting further destruction of the Republic. You are inflicting damage on the PEOPLE. The Republic believes the power resides in the PEOPLE. THE UNITED STATES Corporation and those that support it believe in corporate control. You are evidence to this fact. You have crossed the line. Your allegiance is clearly to the corporation and not to the Republic, THE PEOPLE and Our Rights. You failed to defend Our Constitution. You quickly became the domestic enemy we entrusted you to defend against. There is also genuine concern that you may be aiding a foreign enemy or enemies. Your actions are hostile and repugnant to The Constitution, THE PEOPLE and Our Rights. To those that are paying attention you are fully engaged in mixed war utilizing unconventional weapons.

Under the guise of safety you have illegally destroyed, businesses, careers, lives, families and more. You ignored the legislative branch of government and the process. You utilized decrees, business closures, edicts, mandates, lockdowns, fear mongering, fuzzy math and claims regarding science that were not backed up by any "actual science". THE PEOPLE'S unalienable rights do not end where your fear mongering or ill intent begins. You launched an offensive attack on THE PEOPLE, our businesses and our God given unalienable Rights to life, liberty and the pursuit of happiness.

You fraudulently acquired limited executive power. Your vested power was given to you in error due to your deceit. You abused THE PEOPLE with the power that you fraudulently acquired. Many of your violations against THE PEOPLE are illegal, fraudulent, bogus, without substance, not based in truth, fact, law, science or evidence. Your actions are not supported by the superseding Supreme Law of this Land, namely, the Constitution of The United States of America.

Pursuant to Marbury v. Madison, (1803), all laws repugnant to the Constitution are null and void. Your egregious actions have rendered you entirely null and void. You must vacate the position that you fraudulently occupy. You do not actually hold the position however you have THE PEOPLE hoodwinked into believing you do. We are a Republic, one Nation under God, indivisible, with liberty and justice for all.

At this time it is not THE PEOPLE'S responsibility to put you on trial and attempt to convict you. That will be reserved for another day. You have put THE PEOPLE into this unfortunate position and it is our civic duty to replace you. We are approaching a year of destruction that must end immediately. You are personally responsible for an incredible amount of destruction. As with any poor performing, destructive employee or public servant we simply must replace you and your staff. Your replacement will be a simple process. If you do not vacate you will be escalating your mixed war aggression and conduct to an entirely new level. THIS MUST NOT OCCUR! We are THE PEOPLE and we wish to maintain the peace. You are the aggressor who has launched an offensive attack against THE PEOPLE and it must end immediately.

If you refuse to announce your resignation to the public prior to March 5, 2021 and vacate the office, we will be arriving at 3pm to peacefully escort you from Our building. You have failed miserably at the position you fraudulently acquired. We THE PEOPLE formally rescind all power that was inadvertently, fraudulently vested in you. If you refuse to vacate by the deadline you will be held personally and professionally responsible for any unrest that might occur.

We THE PEOPLE **DEMAND** that you do not order the law enforcement community to attempt to stop or infringe on our peaceful replacement process, duty and Rights.

If you do not resign peacefully and orderly and you are found guilty of any crimes, crimes against humanity, child abuse, insurrection, treason, mixed war, or any other offense **THE PEOPLE will not offer you any leniency whatsoever. We will demand the maximum allowable punishment. There will be no exception. A peaceful resignation is required for any consideration to be made on your behalf.**

We THE PEOPLE believe it is in your best interest to comply with our demands and resign in order for us to peacefully, legally fill the position. This is a public service position and there should be no objection on your behalf.

Your resignation will allow for a peaceful transition and restoration of THE PEOPLE'S dignity, power and Rights. This replacement could have potentially been avoided had you just utilized the legislative branch of government accordingly. The onus is entirely on you and frankly, you should be ashamed of your actions.

You have damaged THE PEOPLE. We are Americans and we are resilient. Once you are replaced we are confident we will fully recover. America will be greater than it has ever been. We will elevate the entire world to greatness alongside us. America will continue to be the beacon of freedom for all of Humanity. We will protect unalienable Rights for all of mankind, while we offer liberty, freedom, and a Constitutional Republic to all that choose to embrace it.

Attention: The law enforcement community must stand down. No law officer shall take orders from any elected public servant or their appointees. You can no longer engage in opposition and mixed war. You must honor your oath to THE PEOPLE and THE Constitution from this point forward. You must allow THE PEOPLE to exercise Our right and duty and you must support the cause. It is for the good of THE PEOPLE and Our Republic.

If resignations do not occur, fifty PEOPLE representing each state will be approaching Our building peacefully at 3pm on March 5th 2021. Three PEOPLE will enter the building. One will be recording the process for our safety. We THE PEOPLE expect law enforcement to escort us and assist in this process as it is your duty and obligation. If you oppose THE PEOPLE or engage defensively or offensively against THE PEOPLE you will be held professionally and personally responsible. You can no longer be an accomplice to the attacks on THE PEOPLE'S God given unalienable rights. It is far past time that the law enforcement community lives up to their oath and supports THE PEOPLES, life liberty and the pursuit of happiness. Law enforcement must protect the Republic and literally turn and face the other direction.

THE PEOPLE are not the enemy, We are the Republic. Law enforcement must become peace officers and must demand prompt resignation from corrupt, destructive politicians in order to keep the peace and avoid civil unrest.

Listed below are violations that are being investigated and must be further investigated. Many have resulted in the filing of federal tort claims. Violations are a matter of public record. In some instances you had the audacity to televise your ignorance and blatant disregard of THE PEOPLES Rights. You have trampled on THE Constitution for The United States of America, our founding documents and our unalienable rights. THE PEOPLE will no longer stand for destruction and your illicit anti American behavior.

We are extremely confident that the National Security Agency and The United States Space Force have everything they need to one day bring you to justice. Once again, at this time THE PEOPLE only require that you step down so further destruction can be avoided. It's clearly in everyone's best interest that you resign.

The list of violations are as follows: Total disregard for THE PEOPLE'S God given unalienable right to life liberty and the pursuit of happiness, breach of the oath of office, 1st, 4th and 9th amendment violations, domestic terrorism under the Patriot Act, orders needed to be placed in fact not fear, treason, sedition, racketeering, deprivation of rights under color of law 18. U.S. code 242, mixed war and unlawful breach of the peace using edicts and fear mongering.

THE PEOPLE could utilize Quo warranto to remove you as you have violated multiple laws. The Corporation would forfeit it's charter due to your vast abuse of powers. Unfortunately the UNITED STATES foreign Corporation was created in secret, illegally in 1871 rendering the system entirely counterfeit. Passing the Act of 1871, Congress committed treason against THE PEOPLE who were Sovereign under the grants and decrees of the Declaration of Independence and the organic Constitution. We THE PEOPLE have no desire to bring a counterfeit public servant, before a counterfeit judge in order to determine yet another counterfeit outcome. It's foolish for a Constitutional Republic to have a trial in a *de facto* court for a mere public servant that can simply be replaced. You would be forfeiting a charter to a counterfeit corporation. It's preposterous considering as stated previously you performed your abuses brazenly as a matter of public record. Your overreach and crimes were done in broad daylight for the entire world to see.

For any leniency to be considered you must resign and also publicly disclose information regarding your indemnity bond. If you believe you received this letter in error and it does not apply to you, by all means ignore it entirely.

We THE PEOPLE demand that law and order be restored under the Constitutional Republic of 1776. It is God's Will and the Will of THE AMERICAN PEOPLE. THE PEOPLE have adopted the 2nd Declaration of Independence. We THE PEOPLE declare our independence. Your immediate resignation is expected.
