1. Cover Sheet

Is there a reason this version is not properly claimed on any of the forms?

2. Deed of Re-conveyance

Shouldn’t we specify the Name is domiciled on the place known as Wisconsin land and soil?

3. Instructions

- Your instruction say to sign in blue ink, the ASA instructions say red, can you please specify the color and style used to sign, is it the printed proper name like the one-pager or is it a signature like the rest of the 928 documents?

4. Certificate of Assumed Names

- This document appears to be done for the all caps Estate using the Military variation of the name (Last, First Middle) acting as the Administrator, is this correct?
- Why is the Returnee the surname only in all caps?
- Why all the discrepancies and typos from the actual Session Law citation referenced?
- Can you please elaborate on the following sentences, they seem to be incomplete and out of place?
- Why is “Common Law Rights” the only proper part of a glossed paragraph and in quotes? Doesn’t this “legally remove it from the document”?
- Under Registration Reason: it says Reinstatement as a noun, is there a reason for this as opposed to “Reinstate the”?
- Business Information: Can you please clarify what this is all referring to, such as what is the Heir Grantee and business being referenced?
- Why is it a Physical Post Office Address listed in all caps? Isn’t this an Entity, not a physical address? What is the USMOI at the end of the address and why is it used here only?

- Owner information: Why True a Real Trade name? Doesn't real mean royal? Why does the STYLE say Bicameral & Surname? Doesn't Bicameral mean two parts, the Christian Name(first middle) and the Surname(last)?
 - In the paragraph "THIS CERTIFICATE IS TO CONDUCT BUSINESS IN COMMERCE IN AN ASSUMED NAME DESIGNED TO ACCOMPANY NEW BUSINESS ACCOUNT REGISTRATION." What is the New Business Account being registered? Why are we doing business in commerce instead of trade?
 - You said the Writ of Habeas Corpus is suspended in all their courts, is this still appropriate? Why is the Lawful Holder in Due Course not ever defined in this document as you, the living man?
 - All violators paragraph again seems like a bunch of incomplete and run-on sentences, can you please explain this in more detail? Why does it pluralize "corporations, associations, or subcontractors, agencies"? What is the reference to Title Order of the Grantee about?
 - Why are you issuing it for the county of and state of, wouldn't you be issuing for JOHN MARK DOE in the county of?
 - You said the Acknowledgment of Head Administrator from Home Office is the British system and this tells them that the office has been left, can you please explain how that is when it says "I take Office" with your proper name and Private Banker the only words that are not glossed over like the rest? Who is the Head Administrator?
 - Please explain why you are now permanently domiciling the Name(s) on the land and soil of the United States? Why is upon used here only?

- Why do we not do Expatriation for the Territorial Name(s)(propercase name)? Why does it say American State Vessel, is this referring to a Trust? Why is it owned and operated by the Military (Last, First Middle) version of the name? 8- Cancellation of All Prior Powers of Attorney
 - Why is this in quotes, doesn't that legally remove it from the document?
