

# Currency

## The Supreme Law

A National Currency is a Credit System and credit is a measurement of value. To measure or count value we use numbers and to these numbers, we give an assumed value; So currency is the use of numbers to measure and exchange value. The assumed value is based on a persons faith, trust, and credit or commitment to the assumed value of the numbers.

A National Currency is more than just a measurement of value; it is a standard to measure the value of all people and all property; in other words, it is a Standard of Judgment to Judge the value of all people.
