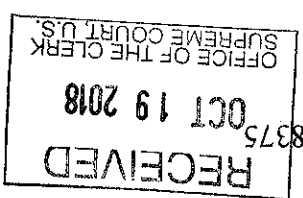

37 Once the Constitutions were adopted, some of the functions of The Supreme Court of the United States
38 of America were shunted off to a new court, The Supreme Court of the United States, which was tasked
39 with ruling on issues arising out of the Federal exercise of the "Delegated Powers".

40 So after 1787 we were left in the inane position of having two "Supreme Courts" --- one for "Non-
41 Delegated" issues arising under the Non-Delegated Powers, one for "Delegated" issues arising under the
42 Delegated Powers.

43 Sometimes "split jurisdiction" cases would arise and both courts would have to rule on different aspects
44 of the same case.

45 I'm reading history and watching employees of the corporate governance in all three branches of
46 government, allegedly, violate 18 USC 3571. We see the proof on the internet not in the media. I am one
47 of the people with this issue.

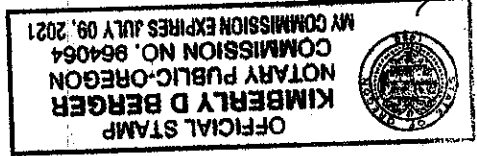
48 When my, Constitutionally, specified "one supreme Court" claiming original jurisdiction in Article III is
